- Future expenses MS Tackling Dummy \$1000.00, Dance/Cheer Poms \$1,050.00, Huddle \$750.00
- Target expense budget for this year \$30,000
- Fall season usually heavy on revenue. In addition expect to recoup expenses from gym chairs and scoreboard sponsorships

# **Old Business:**
