SMSA has also won WIAA State Championships in 2002, 2009, 2011, 2012, 2014, 2015, 2017, 2018 and 2019. Bob Hyland was State Coach of the Year in 1991 and 2019.

The fundamentals taught at SMSA have produced 17 State Championships, 10 State Runners-up and 33 Conference Championships in 51 years. These fundamentals are the same ones that you will learn at our 2022 Football Fundamentals Camp.
