Please be aware that transportation requests can take up to a minimum of (3) business days to route during the regular school year including address changes. Parents must notify the bus company when their student will not ride the bus. If a student does not ride for 5 consecutive days without notifying the bus terminal, the bus will no longer stop at the designated pick-up location (920-921-3003). Drivers will not be expected to wait for students who are not ready to load the bus. Inappropriate and/or unacceptable behavior on the bus will not be tolerated and could result in a suspension of transportation services. All misconduct on the bus will be reported to the school principal for disciplinary action. Please be aware that all buses are equipped with video cameras and GPS tracking systems.
